

REQUIRED DOCUMENTATION FOR ALL CLINICAL NURSING STUDENTS AND FACULTY

All clinical requirements are managed through System 32/Clinical Student, which requires the use of your Avila email. If you have not set up your Avila email, do so immediately. That is where you will receive all communication regarding the School of Nursing and documentation.

All documentation related to vaccinations/immunizations or other testing must be copies of official records provided by your health care provider, lab, or patient portal. All documents must include your name, the name of your physician (portal) or lab group, and the date of the immunization or lab result.

ALL REQUIREMENTS ARE SUBJECT TO CHANGE AT ANY TIME. You will be notified via email by Clinical Student or the School of Nursing of any changes or requirement issues that require your attention.

REQUIREMENT	CRITERIA FOR APPROVAL
BLS	Basic Life Support (BLS)—This must be done through the American Heart
	Association and be the Basic Life Support (BLS) for Healthcare
	Professionals. It must be kept current throughout the program. Failure
	to do so will result in your removal from the program or prevent you
	from participating in clinical experiences.
	Option 1 : Select "click here to register BLS CPR." Use the calendar to select
	and register for a class. Courses for lay rescuers, such as "Heart Saver" or
	through the Red Cross, are not acceptable. The course must include a
	physical hands-on validation of skills.
	Option 2: We hope to have a CPR class in the School of Nursing
	sometime in July. More information will be sent when details become
	available. The cost is \$85 for the complete course and \$70 for the
	hands on portion only with proof of completion of the online portion.

Clinical Orientation Competency	This is completed through Clinical Student. The Clinical
Exam	Orientation manual is available in "Shared Documents" on
	Clinical Student.
Color Blindness Screening	Complete using the screening tool on Clinical Student
Criminal Background Screening	MUST register for and complete through Clinical Student. Pay
	careful attention to all processing requirements, including the
	Family Care Safety Registry. The cost of registration with the
	Family Care Safety Registry is at the student's expense.
Drug Screen	MUST register/schedule through Clinical Student. Once
	registered, you will receive an "invitation" for the screening.
	THE INVITATION IS ONLY GOOD FOR TWO WEEKS. If you miss
	your appointment, you cannot reschedule and will not be

	allowed into the School of Nursing program.	
	You will not be allowed into the School of Nursing program if	
	you receive a positive or positive dilute screen. If you receive a	
	negative dilute screen, you must retest at an additional cost.	
	If you are taking a controlled substance and test positive, you	
	will be required to provide proof from your health care	
	provider. However, there is no exception for marijuana or	
	medical marijuana; a positive finding will result in your not	
	being allowed into the School of Nursing.	
Health Insurance	A copy of your health insurance card or letter from your	
	insurance company stating the date(s) of coverage.	
	If you do not have health insurance, visit HealthCare.gov. You	
	are entirely responsible for the type of coverage you get.	
Physical Activity Release form	Download the form, have it signed by a healthcare professional	
· · ·	(MD, DO, PA, or NP), and upload it.	
Hepatitis B (HepB)	A positive titer or waiver is required.	
	Titer documentation must provide the student's full name, date	
	of birth or medical record number, the date of the blood draw,	
	and the reference range for the results.

	Though not recommended, the vaccination can be waived.

Measles, Mumps, Rubella	Official documentation showing the two-vaccination series OR	
(MMR)	a positive titer. All titer documentation has to contain the	
	student's full name, date of birth or medical record number,	
	the date the blood draw occurred, the result, and the reference	
	range for the result.	
Varicella (Chicken Pox)	Official documentation showing the two-vaccination series OR	
	a positive titer. All titer documentation has to contain the	
	student's full name, date of birth or medical record number,	
	the date the blood draw occurred, the result, and the reference	
	range for the result.	
Tetanus-Diphtheria-Acellular	Vaccination must be less than 10 years old. If your vaccination	
Pertussis (Tdap)	will expire within 24 months of the program's start, it is highly	
	recommended that you get an updated vaccination so you will	
	not be at risk of becoming non-compliant.	
Tuberculosis Screening (TB)	Two negative TB skin tests, one negative blood test, and one	
	annual test thereafter.	
CNE/KCANE TB Risk Assessment	Download, complete, sign, and upload if required due to TB	
Form	vaccination or previous positive TB screen.	
FOIIII	vaccination of previous positive TB screen.
